I/We hereby apply for a Social Membership at the Ahwatukee Recreation Center (ARC) in accordance with the following terms and conditions.

TERMS AND CONDITIONS

1. Social Memberships are available to anyone who meets the 55 years of age requirement.
2. Social Members must renew by January 31st of each year. If a membership is not renewed by the expiration date above, the membership shall be made null and void.
3. Social Memberships must abide by the existing ARC Rules and Regulations. A copy of the ARC Rules and Regulations are provided at the time application is accepted
4. Social Members are entitled to full usage of the ARC Facilities and may participate in all events sponsored by the ARC including membership in special interest groups and clubs. Fees may apply.
5. Social Members are not entitled to vote or serve on the Board of Directors but they can serve on a standing committee.

6. Social Members and guests must abide by existing rules and regulations pertaining to all members. Social members may bring guests (6 times a year).
7. Social Memberships are non-transferable. Loaning of a member's card shall be cause for immediate cancellation of membership without refund.
8. Membership cards must be presented to the ARC Front Desk upon entering the ARC facility.
9. Membership fees are not refundable.
10. The ARC may cancel a Social Membership at any time for cause, such as conduct conflicting with the ARC Rules and Regulations.
11. In the event that the ARC cancels a Social Membership no refund will be given.
12. The Social Membership program may be cancelled in its entirety at the end of any membership year by the Board of Directors.
13. To obtain a membership card(s), the applicant(s) must submit this completed form along with a copy of proof of age and identification to the ARC Front Desk Attendant. The membership fee is due and payable at the time this form is submitted.

2020 SOCIAL MEMBERSHIP ANNUAL FEES

1. A **12-Month Couple Membership** is available for **two people residing at the same address** (proof of address required) for \$1001.00 (includes one-time \$50 initiation fee).
2. A **12-Month Single Membership** is available for **one person** for \$683.00 (includes one-time \$50 initiation fee).
3. A **6-Month Couple Membership** is available for **two people residing at the same address** (proof of address required) \$658.00 (includes one-time \$50 initiation fee).
4. A **6-Month Single Membership** is available for **one person** for \$490.00 (includes one-time \$50 initiation fee).

Note: The \$50.00 Initiation fee must be paid by all new member(s) or any member(s) who have been inactive for more than 6 months.

Furthermore, in consideration of my Social Membership at the Ahwatukee Recreation Center, I/We release the Ahwatukee Recreation Center (employees, officers, or volunteers), from any claims, demands, and/or causes of action arising from my membership at this facility.
